#### **OABO INSURANCE FREQUENTLY ASKED QUESTIONS**

Q: Am I covered if I work a game with a school teacher, out of Province official, or out of country official who is not an OABO member?

A: YES, all OABO members are covered for all basketball official activities (except social activities) that are sanctioned or authorized by OABO. This includes games officiating, all related training activities, clinics and tournaments for basketball officials in and outside of Canada. For those members traveling outside of Canada you must notify the OABO Secretary/Treasurer before you leave Canada.

Q: If I get injured during a game would I receive monies for loss of time from my full time employment?

A: NO

Q: If I get injured during a game would I receive monies for games I had to turn back due to the injury?

A: NO

Q: What coverage does our policy actually have for me?



Q: If I am in a car accident on the way to a game I am to be officiating at, am I covered?

A: If you travel to the game with 2 or more fellow officials, the OABO insurance policy would cover you for personal accident and liability coverage but not for damages to your vehicle.

#### Q: Are there limitations to the Benefits of the Policy

A: Yes, a list can be found in the PDF file called Insurance Information and Coverage from you Local Board Secretary or the OABO Secretary/Treasurer. Most importantly, this plan is secondary to any existing medical plan and no payment for any benefits that are available under any government health plan, whether the Insured is enrolled in such a plan or not.

#### Q: How do I make a claim?

A: Your Local Board Secretary has a copy of all the forms and a step by step procedure is listed in the PDF file called Insurance Information and Coverage.

#### Q: Are members covered for Liability.

A: Yes. OABO members need to be aware of incidents that occur in games especially injuries to players. A standard incident report can be found under the Secretary/ Treasurer tab on the <a href="https://www.oabo.ca">www.oabo.ca</a> web site. The form should be completed, saved and copied to your local board executive and the OABO Secretary/Treasurer.

# Lessons from the Police Athletic League By Sarwar Qureshi

The Police Athletic League (PAL) is a program that runs in conjunction with the Boys and Girls Club to provide opportunities for youth to take part in organized sports. The Boys and Girls Club of Ottawa has a basketball division of the PAL and on Saturday September 18th an all-star team was selected from players within the league to play against the Ottawa police in what is the finale to a busy summer of basketball. Murray Shoup and I from OVBABO (Ottawa Valley Board of Approved Basketball Officials) were invited to officiate the game as well as stay for the dinner and awards banquet.

While the game was extremely competitive and highly skilled – overtime with a final score of 110 – 106! And the dinner was quite bountiful and delicious – Lone Star takeout complimented with homemade Somali cooking. And the banquet was quite dazzling – numerous

awards and speeches along with Murray and I presenting the sportsmanship award to very deserving individuals. I was especially touched by the underlying reason of having the PAL, which is the reason for the article all together.

In talking with some of the police officers at dinner one of the goals of the league is to build friendships between law enforcement officers and children with the view that positive attitudes can be developed by the youth towards police officers. This was evident over the course of the entire afternoon and evening as I observed interactions between the two groups on the basketball court and socially afterwards. An officer went on to explain that if an individual respects an officer on the court, they are more likely to respect the rules an officer enforces off the court. At the banquet a powerful presentation was delivered by one of the officers about the perils facing youth today and many examples were given of people falling into various traps which got them into trouble with the law. I am certain the youth took the message better because of the respect they developed for the officer through the PAL.

Overall Murray and I felt very appreciative of being invited to such an event. As representatives of OVBABO, OABO, CABO, and officials in general we realized that our interactions on and especially off the court with the youth helped foster their respect for officials similar to the concepts described above with officers. While this is far secondary in importance to developing respect for law enforcement, I feet as officials we should take part in such events whenever the opportunity arises. By doing so, it helps us appear more personable, friendly, and human which in turn will help our future interactions with the same coaches, players, and spectators involved. Not

to mention that you can also learn something from the youth – which is worth another article altogether.



### Interpreter's Message by Sandy Bibeau OABO Interpreter

Dear Fellow Officials:

Wow! The girls' high school season goes by amazingly fast. I had an opportunity to watch the bronze and gold finals for the OFSAA "A" in Welland. An exciting finish in both games, won on last shots. The officiating was great too!

All local boards will have now received the OCAA and FIBA exams. Anv official who's name is submitted for the OCAA provincial men's' and women's championships, must write this exam. The FIBA exam passing grade is specific to your National Officials Certification Program level. Level 1 = 70%, Level 2 = 80%, Level 3 = 86%, Level 4 = 86%, Level 5 = 86%. Each year you will need that specific passing grade, to qualify or retain that level. Your level may be checked by logging on to the OABO website www.oaboadmin. Go to Login (email address) and Password (either "trial" or whatever you have changed it to). Level 4's are still in the approval stage with CABO.

As the West Women's OUA Commission Rep, I was able to join the officials and supervisor Guy Cipriani at their opening meeting. I welcomed the officials to a new season and encouraged "all" to rely on me for assistance with the West Women's Panel and its operations.

This must be the age of conference calls. Our first IAABO/FIBA call was held Nov. 21, 2010. Peter Webb of

IAABO and me hosted the information phone meeting, along with our FIBA carded official Rich Stehlik. Although rich in content, the call was "not" greatly attended. Something I wish to rectify for the MARCH 20, 2011 call date. Notice the darkened, underlined DATE!!!!! These are opportunities to get bang for our educational dollar and to NOT take part (at least have another member of your board participate), is a large disservice to your board and our grassroots education.

The regular IAABO conference calls are a wonderful opportunity for IAABO interpreters to share and gain information across Ontario and the United States. A new conference call will be scheduled in the New Year.

On yet another conference call; the Windsor Board of Officials, the University of Windsor, CABO and OABO are teaming up for a FIBA clinic to be hosted March 2011 at the CIS Women's National Championships in Windsor. Jim Walsh, Paul Carter, Mike Harvey and myself are working together to arrange this officiating event, which will be advantageous to the university and the grassroots official alike. Stay tuned!!

If you think I should still have some more time to spare, I do! Basketball Ontario has founded a "Learn to Train Committee". As the officiating representative, I have taken on a role

to assist with the development of protocol for "Parent Education". Yes it is never too late to learn, at least not about proper behaviour at the basketball site. How about an online tutorial preceding registration? Works for hockey why not basketball?

I would like to include here the updated interpretation from Rich Stehlik and the FIBA rule changes:

"I have received the clarification about when the 8 second count ends from Paul Deshaies (National Interpreter) and since I gave the FIBA Rule Change presentation at the OABO conference in September I feel as though I need to let you know the change in Interpretation. The correction comes from Paul, Fred Horgan and even Lubo Kotleba based on an original inquiry by Tanner Cervo at a clinic in South America.

The 8 second count ends in two ways when advancing up the floor:

1) When a non-dribbler is holding a ball with both feet entirely in the front court.

2) When a dribbler has both feet entirely in the front court and dribbles the ball so that the ball contacts the front court only.

Note: the slideshow presentation that is on the OABO website (Ontario Interpreter>Rules>Rich Stehlik FIBA Rule Changes PowerPoint Presentation) is correct and can still be used. It is the concept of what puts a

foot/player/ball into the front court that has changed. Makes much more sense in my humble opinion

Thank you Rich Stehlik"

Thank you Mauro Sardone for forwarding me an NCAA rules interpretation that has now been passed on to the OCAA coaches and athletic directors. Please make your OCAA officials aware of this important interpretation,

#### **SWINGING OF THE ELBOWS**

Effective with the 2010-11 season, more than incidental contact with a defender about the shoulders (throat or head) with an elbow must be ruled a minimum of an intentional foul. Elbow contact below the shoulder will continue to be penalized by a common foul, an intentional foul or a flagrant foul in the judgment of the official.

If the contact with the elbow is deemed to be a result of **excessive swinging of the elbows**, the penalty will continue to be a flagrant foul regardless of the area contacted.

Continue to forward me questions or comments. It is always welcomed and as you know, I always do my best!

# IAABO Region Nine Representative News & Views December 2010
